2018 SCHEDULE OF FEES

TAS PLAN REVIEW SERVICES: Fee is based on estimated construction cost. Plan reviews typically take 2 weeks to complete.

TAS INSPECTION SERVICES: Fee is based on estimated construction cost. Inspections are typically scheduled 1-2 weeks after formally ordered.

- Notes:**
- 1) Fees listed below do not include TDLR Registration Fee, currently \$175 (or \$300 for late submittals), for each EABPRJ project. Since Oct 2008, this fee is paid by credit card when a project is registered online for EABPRJ#. If you are registering the project online for EABPRJ number then you will pay this fee via credit card. If our office is going to register the project online for the EABPRJ# then this fee must be remitted to our office as we will have to pay by credit card at time of EABPRJ registration.
 - 2) Inspections outside of Bexar County will incur Mileage plus Travel Time expenses at the rate stated in EXPENSES section.
 - 3) **RE-Inspections, if desired, to verify corrections is an additional service requiring an additional fee equal to 50% of the original Inspection Fee + Mileage/Travel Expenses if outside Bexar County. Additional RE-Inspection Fees are due prior to the requested RE-Inspection.**
